### Homeless Youth Definitions

<p><b>At risk of being homeless:</b> When a student's housing may cease to be fixed, regular, and adequate. For example, a student who is being evicted and has been unable to find fixed, regular, and adequate housing.</p> <p><b>Homeless:</b> Lacking fixed, regular, and adequate housing.</p>	<p><b>Self-Supporting:</b> When a student pays for his own living expenses, including fixed, regular, and adequate housing.</p> <p><b>Unaccompanied:</b> When a student is not living in the physical custody of a parent or guardian.</p>	<p><b>Youth*:</b> A student who is 21 years old or younger or still enrolled in high school as of the date he/she signs the application.</p> <p><i>Students who don't meet the definition of youth because they are older than 21 (and not yet 24) and who are unaccompanied and homeless or self-supporting and at risk of being homeless qualify for a homeless youth determination.</i></p>	<p><b>Housing</b></p> <p><b>Fixed:</b> Stationary, permanent, and not subject to change.</p> <p><b>Regular:</b> Used on a predictable, routine, or consistent basis.</p> <p><b>Adequate:</b> Sufficient for meeting both the physical and psychological needs typically met in the home.</p>
