## Am I Eligible?

All full-time students carrying 12 credits or more, and part-time students carrying 6 credits or more, attending Prairie State College are eligible to enroll in this Plan on a voluntary basis. Students are covered for the period for which premium has been paid. Eligibility requirements must be met each time premium is paid to continue Coverage. Insured Students who enroll in the plan may also enroll their eligible dependents. Dependents must be enrolled for the same period of coverage as the insured student.

## How Do I Enroll?

The deadline to enroll in the Annual and Fall Plan is 9/30/2020 and the deadline to enroll for the Spring term is 2/28/2021. ### GENERAL EXCLUSIONS

In addition to any benefit-specific exclusion, benefits will not be paid for any **covered injury, sickness, covered loss or covered expense** which is independently caused by or results from any of the following unless coverage is specifically provided for by name in this **certificate**:

1. Any service, treatment or supply that is not considered **medically necessary** as defined in this certificate.
2. Expenses **incurred** after the date insurance terminates as to a **covered person**, except as specified in the extension of benefits provision; and the end of the **policy term**, even if **incurred** for continuing services or treatment of a **covered injury or sickness**.
3. Benefits provided by a Government plan (except Medicaid and other public assistance plans).
4. Injuries compensable under Workers' Compensation law or any similar law.
5. Sojourns or **Personal** deviations are not covered.
6. Declared or undeclared **war** or act of **war**.
7. Commission or attempt to commit a felony or an assault.
8. Commission of or active participation in a riot or insurrection.
9. Treatment of a **pre-existing condition** as defined herein.
10. Aggravation, during a **covered activity**, of an injury the **covered person** suffered before participating in that **covered activity**, unless **we** receive a written medical release from the **covered person's physician**.
11. Practice or play in any sports activity intercollegiate tackle football **intercollegiate sports** semi-professional sports or professional sports, including travel to and from the activity and practice except as specifically listed in the Schedule of Benefits.
12. Flight in, boarding or alighting from an aircraft or any craft designed to fly above the Earth's surface, except as:
  - a. A fare-paying passenger on a regularly scheduled commercial or charter airline.
  - b. A passenger in a non-scheduled, private aircraft used for pleasure purposes with no commercial intent during the flight.
  - c. An ultra-light or glider.
  - d. A passenger in a military aircraft flown by the Air Mobility Command or its foreign equivalent.
13. Travel in or on any on-road and off-road motorized vehicle that does not require licensing as a motor vehicle.
14. An **accident** if the **covered person** is the operator of a motor vehicle and does not possess a valid motor vehicle operator's license, unless: (a) The **covered person** holds a valid learner's permit and (b) The **covered person** is receiving instruction from a Driver's Education Instructor.
15. Travel or activity outside the contiguous United States, Alaska, Hawaii and the territories and possessions of the United States, Canada or Mexico.
16. **Voluntary** ingestion of any narcotic, drug, poison, gas or fumes, unless prescribed or taken under the direction of a **physician** and taken in accordance with the prescribed dosage.
17. An **accident** that occurs while on active duty service in the military, naval or air force of any country or international organization. Upon **Our** receipt of proof of service, **we** will refund any premium paid for this time. Reserve or National Guard active duty training is not excluded unless it extends beyond 31 days.

18. Treatment in any Veteran's Administration, Federal, or state facility, unless there is a legal obligation to pay.
19. Examination or prescriptions for, or purchase, repair or replacement of, eyeglasses, contact lenses except due to a **covered accident** as described elsewhere in this **certificate**.
20. Hearing examinations or hearing aids, or purchase, repair or replacement of.
21. Wheelchairs, braces, appliances, orthopedic braces, or orthotic devices.
22. Operating any type of vehicle while under the influence of alcohol or any drug, narcotic or other intoxicant including any prescribed drug for which the **covered person** has been provided a written warning against operating a vehicle while taking it. Under the influence of alcohol, for purposes of this exclusion, means intoxicated, as defined by the laws of the jurisdiction in which the **covered accident** occurred.
23. Rest cures, long-term care or custodial care.
24. Cosmetic surgery or care, or treatment solely for cosmetic purposes, or complications therefrom. This exclusion does not apply to:
  - a. Cosmetic surgery resulting from a **covered accident**, if the **covered person's** initial treatment had begun within 90 days of the date of the **covered accident**;
  - b. Reconstruction incidental to or following surgery resulting from a **covered accident** or **sickness**.
25. Any elective or routine treatment, surgery, health treatment, or examination, including any service, treatment or supplies that: (a) Are deemed to be experimental or investigational; and (b) are not recognized and generally accepted medical practice in the United States.
26. Services or treatment provided by persons who do not normally charge for their services, unless there is a legal obligation to pay.
27. Repair or replacement of existing dentures, partial dentures, braces or bridgework.
28. Treatment or services provided by the **covered person's immediate family**.
29. Personal services, or comfort/convenience items such as television and telephone or transportation.
30. Orthopedic appliances used mainly to protect an injury so that the **covered person** can take part in **intramural, interscholastic**, club or recreational **sports**.
31. Expenses payable by any automobile insurance **policy** without regard to fault.
32. Services or treatment provided by an infirmary operated by the **policyholder**.
33. Treatment or service provided by a private duty **nurse** except due to a **covered accident** as described elsewhere in this **certificate**.
37. Charges for hot or cold packs.
38. Custodial Care service and supplies.
40. Expenses that are not recommended and approved by a **physician**.
41. Repair or replacement of existing artificial limbs, eyes and larynx, unless damaged or destroyed in a **covered accident**.
42. Participation in any sports activity not specifically authorized, sponsored and supervised by the **school, policyholder**, whether or not it takes place on **school, policyholder** premises or during normal **school** hours, including but not limited to snowboarding, skateboarding, motorcycle racing, racing rocket-powered, jet propelled or nuclear-powered vehicles (or any other activity to be excluded).
43. Any expenses in excess of **usual and reasonable charges** except as provided in this **certificate**.
44. Loss resulting from playing, practicing, traveling to or from, or participating in, or conditioning for, any professional sport.
45. Racing or speed contests, skin diving, or sky diving, mountaineering (where ropes or guides are customarily used), parasailing, sail planing, hang gliding, bungee jumping, travel in or on ATV's (all terrain or similar type vehicles), or other hazardous sport or hobby.
46. Non-physical, occupational, speech therapies (art, dance, etc.).
47. Modifications made to dwellings.
48. General fitness, exercise programs.
49. Hypnosis.
50. Rolfing.
51. Biofeedback.
52. Acupuncture charges.
53. Chiropractic care or spinal manipulation charges.
54. Care or treatment of allergies, including allergy testing.
55. Diagnosis and care or treatment of acne.
